## Return to Campus Resources

### Plans announced for Phases 2 and 3 of returning to full operations

Today the University announced plans for Phases 2 and 3.

- Phase 2 will begin on Monday, July 20, as supervisors, personnel who perform mission critical/time-sensitive functions and appropriate support personnel return to campus.
- Phase 3 will begin on Monday, August 10, when all faculty and staff return to campus for Fall Semester, unless they have been approved for telework.

It is important that all members of the community are aware of the many safety precautions being taken by the University, are knowledgeable of the

resources available to them, and understand their individual responsibility to abide by the guidelines issued by the GDPH, CDC, USG, and UGA to contain the spread of the coronavirus. Please review the July 7 campus message for more information on health and safety efforts on campus.

#### **Face coverings will now be required**

Effective July 15, 2020, the University of Georgia—along with all University System of Georgia (USG) institutions—will require all faculty, staff, students, and visitors to wear an appropriate face covering while inside campus facilities/buildings where six feet social distancing may not always be possible. Face covering use will be in addition to and is not a substitute for social distancing. Face coverings will not be required when alone in an enclosed office or study room, in campus outdoor settings where social distancing requirements are met, or for students in their own residence hall rooms or suites. Anyone not using a face covering when required will be asked to wear one or must leave the area. Repeated refusal to comply with the requirement may result in discipline through the applicable conduct code for faculty, staff, or students. Reasonable accommodations may be made for those who are unable to wear a face covering for documented health reasons; employees seeking such an accommodation should follow the ADA accommodations process outlined [here](#).

#### **Technology for fall classes**
